- Minimum standard – Therapist. Certificate IV Remedial Therapies (Massage) or equivalent as recognised by ISPA, ASPA and the AAMT (Australian Association of Massage Therapists).
- Management & Administration positions – Minimum 2 years equivalent experience in the spa industry.
- Association Membership (National or International)
- Current Senior First Aid and CPR certificate
- Business Bank Account
- Visas, work permits (overseas applicants – all requirements must be recognised in Australia for a minimum of 6 months). You need to show proof of application.
